Welcome to the Pinnacle Wellbeing Plus Limited's privacy policy. We respect your privacy and security of your data and committed to protecting it. The personal data which we hold is subject to certain legal safeguards specified in the General Data Protection Regulation ('GDPR'), the Data Protection Act (DPA) 2018

The type of personal information we collect.

Personal information (personal data) is any information that can be used to identify a living person.

We currently collect and process the following information:

- Your first, middle, surname, maiden, and previous names.
- Your title, marital status, date of birth and gender.
- Your contact details such as your address, telephone numbers, email address and/or webpage.

How we get the personal information?

- Most of the personal information we process is provided to us directly by you.
- We also receive personal information indirectly, from the following sources in the following scenarios:
 - i. Automated technologies as you interact with our website, we may automatically collect your browsing action and patterns via cookies.
 - ii. We may receive personal data about you from analytics providers, such as Google, who may be based outside EEA.

- iii. We may also receive your information from our affiliates or associated partners.

Why we get the personal information?

We use the information that you have given us to fulfil our contractual obligations to you.

Under the General Data Protection Regulation (GDPR) and Data Protection Act 2018 (DPA) the lawful bases we rely on for processing this information are:

(a) Your consent. You can remove your consent at any time. You can do this by contacting us at above address.

(b) We have a contractual obligation.

(c) We have a legitimate interest.

How we store your personal information

Your information is securely stored on our UK based servers. We do not share or transfer your data to countries outside EEA. We may transfer your data to countries outside EEA only by your request and explicit consent.

We keep data as per our retention policy. Please refer to our retention policy, this can be found on our website or can be requested from our DPO, where the details listed below. We will then dispose your information securely.

Your data protection rights.

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the the right to object to the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
